**Welcome:**

We are pleased to have opened our new outpatient Psychiatry practice at BWFH. Please join us in welcoming Altagracia Ramirez, MD, Mohammed Issa, MD, Teresa Delgado, LICSW, Ash Nadkarni, MD, Jonathan Runge, Psy.D., and Sharon Manning, LICSW to the BWH Department of Psychiatry. We are also recruiting for another Psychiatrist and a Psychologist. Later this month Amanda Leone, LICSW and Elisabeth Maguire, LICSW will be joining us.

**Dr. Ramirez** is an attending psychiatrist in the new BWFH Psychiatry Outpatient Clinic. She completed the BWFH Adam's House Fellowship, provides weekend psychiatric coverage at BWFH, and was an attending psychiatrist at BWH. Most recently, Dr. Ramirez was at the Martha Eliot Health Center, providing medication management to patients, comprised primarily of adult Latinos and African-Americans. She received her medical degree and completed psychiatric residency training at the University of Massachusetts Medical School.



**Dr. Issa** is an attending psychiatrist in the BWFH Addiction Recovery Program's Suboxone treatment program. He will also see patients at the BWH/BWFH Pain Clinic. He completed Forensic Psychiatry Training in the Department of Behavioral Medicine and Psychiatry at West Virginia University School of Medicine, a Pain Fellowship in the Department of Anesthesiology, Perioperative and Pain Medicine at BWH and an Addiction Psychiatry Fellowship in the Department of Psychiatry at Yale University School of Medicine. Dr. Issa is also the recipient of the 2013 American Academy of Pain Medicine's Pain Medicine Fellowship Excellence Award.



**Teresa Delgado, LICSW** is the first full time clinical social worker appointed to the new BWFH Psychiatry Outpatient Clinic. She is an experienced clinician, most recently working at the Martha Eliot Health Center. Prior to that, Ms. Delgado worked at Southern Jamaica Plain Health Center, Cambridge Health Alliance, Latino Health Institute, The Home for Little Wanderers, and The Boston Public Health Commission. Ms. Delgado received her Master's Degree in Social Work from Boston University, is a CADC: Certified Addictions Counselor, and is bilingual in Spanish and English.



**Ash Nadkarni, MD** attended medical school at Northwestern University, completed her Psychiatry Residency at Boston Medical Center, and worked at the Lahey Clinic for 1.5 years before joining us. Her interests are at the interface of psychiatric and medical illness. She is collaborating with the Inflammatory Bowel Clinic at 850 in a study and also doing evaluations and treatment planning in IBD patients with high medical utilization.



**Jonathan Runge, Psy.D.** is a cognitive behavioral therapist who came to psychology recently as a second career after many years as a travel writer. He is a Stanford-CSPP program graduate. Along with seeing individual patients he is starting an outpatient CBT group therapy for depression at 850 in June.



**Sharon Manning, LICSW** earned her masters in clinical social work from the Smith College School for Social Work. She then completed a fellowship program at the Massachusetts Institute of Psychoanalysis in Brookline, MA. Before joining us, Sharon was a social work consultant for the Farren Care Center in Turners Falls, MA.

**Robert Boland, M.D.** has been recruited to be our Vice Chair for Education. In his Vice Chair role, Bob will oversee, integrate and advance all aspects and levels of our department's educational mission. He will join Christie Sams, M.D. as Co-Director of the Harvard Longwood Psychiatry Residency Training Program, where he will also serve as the Brigham and Womens Hospital site director. He will retain his role as Director of the Division of Medical Psychiatry, a premier program that he has developed exquisitely.

## Updates:

### Clinical Updates:

- **iCMP program**: David Gitlin and Sejal Shah are involved in the the Integrated Care Management Program (iCMP) which has the goal of helping high health care resource-utilizing patients achieve a customized health care plan to address their specific needs. Dave and Sejal serve as the psychiatric consultants to the PCPs, social workers, and nurse case managers to provide education and case reviews for patients with behavioral health issues
- **BWFH has opened its OP Psychiatry clinic** with the addition of Altagracia Ramirez, MD and C.Teresa Delgado, LICSW as its first clinicians. The clinic is working closely with Jay Baer, MD, Director of the department's OP Psychiatry division to develop departmental- wide triage functionality as well as uniform intake, evaluation, and billing procedures.
- The **suboxone program** is thriving under the leadership of Joji Suzuki, MD. We have accepted over 150 new patients into the program in just one year.
- In May, Dr. Joffe co-directed a 2-day Harvard Medical School/Brigham and Women's Hospital **CME course**, Update on Neurology and Psychiatry of Women: What Every Practitioner Needs to Know, with Mary (Angela) O'Neal, MD , Director of the Women's Neurology Program in the Department of Neurology at BWH. The course was a highly successful educational opportunity for clinicians to learn about the subspecialty care of women with psychiatric and neurologic conditions during which a series of lectures were presented by expert clinicians and researchers from BWH, many of whom were from our Psychiatry Department. Almost 90 people attended the conference, including psychiatrists, psychologists, social workers, neurologists, internists, OBGYN, family medicine, pediatricians, endocrinologists and more from Massachusetts, the Northeast, and throughout the US and Canada.
